| 3 | Delta College | Does not charge. | Faculty and Staff pay a small fee for reserved parking in restricted lots. (\$35/annually) | |

| 6 | Grand Rapids Community College | Downtown GR campuses only (no charges at MTEC or Regional Ctr locations). \$3.50 "per swipe" to raise gate when leaving ramp. | | Limited amount of reserved parking for students in 2 off-campus lots - fees range from \$90-\$125/sem. Faculty/staff pay for parking during the 8-month academic year. Monthly rates range from \$5-\$20 depending on employee group and level. Enforcement by Campus Police. Most officers participate in parking enforcement during their shifts. |
| 7 | Henry Ford Community College | Does not charge. | | \$25/sem. Infrastructure Fee supports lot maint. |

| 13 | Lansing Community College | Students pay Student Support Fee of \$11/billable hour. Fee supports tutoring, advising, counseling, library, computer lab and parking. Parking gets \$5/billable hour. | Faculty and Staff are given employee stickers and do not pay for parking. | Students are issued stickers that allow parking in designated lots. Public Safety is charged with parking enforcement. Uses student cadets in enforcement (3.5 FTE). Run as an Aux Svc. Costs include maint & rep of parking ramp and lots, plowing, rental of other lots, etc. |
